Certificate.
- Supply us with a recent set of markings taken before the horse is exported. All exports require new markings and we cannot accept a copy of the passport markings.

MY HORSE IS A BREEDING ANIMAL LEAVING FOR A PERIOD OF LESS THAN NINE MONTHS

- You need to complete the application for temporary export form, ticking the box informing us the horse is being exported temporarily, the box requesting the Breeding Clearance Notification and, if you require, the box requesting an Animal Health Act (A.H.A.) Certificate.

- You need to contact the Names Department at Weatherbys to arrange for a Racing Clearance Notification (RCN) to be forwarded to the Foreign Authority.
